JAMAICA CHURCH MISSIONARY SOCIETY REPORT to the 152nd SYNOD

1. INTRODUCTION

This will be the first Annual General Meeting in two (2) years, and we give thanks that although we are still having some effects of the COVID 19, the severe protocols have been lifted which has allowed for the 152nd Synod to be held face to face. As challenged as we were over the past two years, we do give thanks for the new exposures of ministry and the benefits derived thereof. A number of activities were restricted due to the enforced COVID 19 protocols, but embracing what we have learnt, coupled with the returned flexibility we will continue with increased energy into the mission field.

Over the period under review, we noted the decline in a number of mission activities, the decline in persons attending and returning to church post-COVID and the severe financial challenges being experienced. The latter has negatively impacted contributions to the Jamaica Church Missionary Society (JCMS), but notwithstanding, the Society has been able to give assistance within the available resources. There are post-COVID challenges – societal, financial, parental, schools etc – not experienced or imagined in recent times, and the JCMS has its role in finding or supporting solutions to these problems.

In light of all this, and in solidarity with the Synod theme, 'A Renewed Church for a time of Critical Social Change', the Society will intentionally focus on the developmental strategies for our missions throughout the Diocese, and the operations throughout their respective communities.

The Annual Report for 2022 continues to be reflective of the challenges experienced during the year:

- o Curtailment of a number of activities
- o Increasing indebtedness of the Missions
- o Reduction in inflows for General Contribution
- o Lower than projected disbursement on projects

We must however commend the creative endeavors of some of our congregations, and continue to encourage our members to 'think outside the box'. Working with our Deanery Representatives, we anticipate revived energy for 2023.

2. THE GENERAL COMMITTEE

The General Committee formulates policies for Missionary work in the Diocese for the approval of Synod, and implements and supervises those that are approved. The Committee also determines the level of assistance extended to Missions based on reports from the Deanery

Representatives and requests submitted through the Deanery and Regional Councils. In this regard it should be noted that the Deanery Representatives are important links between the Missions and the JCMS, as the Society relies on the active participation in the decision-making process. The JCMS again implores the Deanery Councils to brief prospective appointees as to their roles and responsibilities and seek the assurance of their willingness to serve.

The Rt. Rev. Garth Minott, Suffragan Bishop of Kingston was appointed as Chairman effective June 15, 2022. The Committee members are as listed below:

Five (5)meetings were held during the year. There was no representative from the Deanery of St. Catherine. *See Appendix 1* for attendance at meetings.

3. DIOCESAN MISSIONS

The Bishop as President of the Society may designate any Mission to be a Diocesan Mission and may make special Regulations for the administration, pastoral care and financial management of the Mission which is usually not directly attached to a Cure. There are currently three (3) Diocesan Missions.

I. Discovery Bay Mission

The Discovery Bay Mission (DBM), located in Discovery Bay, St. Ann, began in June 2005, and is led by a core of eight (8) committed lay persons who are members of neighbouring Anglican Churches. The DBM meets as a community on Sunday evenings at the Roman Catholic Church in Discovery Bay. The Very Rev. Richard Tucker celebrates the Holy Eucharist once monthly. The Brotherhood of St. Andrew groups in Ocho Rios and St. Ann's Bay also offer assistance to the mission. During the pandemic, the Mission continued to give assistance to the families in Old Folly, offering support with grocery supplies, and assisting children with school fees and other necessities. The Mission has indicated its intention to re-stimulate the ministry at Folly.

II. Spot Valley

The missionary activities in the Spot Valley community of Montego Bay have been suspended for some time. This property will be given some critical attention during 2023.

III. Longville Park Mission (LPM)

The Longville Park Mission is physically located in Phase 3 of the Longville Park development. The Diocese owns two (2) properties, Lot # 572 Olive Road, where the Mission House is located, and Lot #859 Juniper Road, the proposed site for a church building. After a break due to COVID-19, the JCMS has once again embarked on mission and evangelism activities in the community, and in this regard, the construction and evangelistic committees have been resuscitated.

Construction Committee: The committee will be responsible for the physical construction at the Juniper Road site. The status letter from the National Housing Trust, and the approval from the Clarendon Municipal Corporation (pending the architectural drawings) have been received. The site has already been cleared for the placement of the 40' container in hand.

Evangelistic Committee: Just prior to the outbreak of COVID 19, the Committee had developed a plan with which to begin the campaign. This had to be aborted. The now revised plan with the assistance of the Church Army and the Associate Evangelists in particular is being implemented. As a re-entry to the community, a Health Fair preceded by 'walk through' and door to door invitations on two weekends, was staged in March 2023. In addition to the medical services offered, there was spiritual and mental counselling. There was good participation by members of the community, and it was evident that the services were well received. The fair which was held at the nearby Longville Park Phase 3 Community Center, facilitated medical checks for over forty (40) persons and was well supported by the Clarendon Municipal Cooperation and Health

Department, the National Health Fund, the Lions Club of Clarendon, the National Parenting Commission, the Mothers' Union, Brotherhood of St. Andrew, doctors, nurses and other health related institutions. Other mission and evangelism activities will be staged on an on-going basis.

Lot # 572 Olive Road, Mission House

In adhering to the COVID protocols activities at the Mission House were suspended. During the period, Sister Alvarine 'Gem' Roberts continued to maintain contact with the families and children of the community. Since Sis. Gem's retirement in July 2022, the ministry ceased and she vacated the residence in November 2022. The JCMS is indeed thankful to Archdeacon Johnson and the St. Gabriel's family for their kind assistance in securing the assets in November. The Society has since been able to secure short-term rental of the premises. This will facilitate security and some required maintenance of the facility.

4. MISSION ACTIVITIES

Deanery representatives are being urged to keep the JCMS informed on the spiritual, physical and financial activities in their respective Deaneries. Many representatives have difficulties getting the information from the missions and the JCMS appeals for the process to be supported, so that where necessary action can be taken. In this regard, the Portland Deanery is highlighted for best practice..

The Deanery representative gave a vivid picture of the challenges in the All Saint's, Fellowship Cure. There were physical challenges with respect to actual location and deterioration of the buildings; there were leadership concerns s there had been no clerical leadership for a number of years, and there was need to develop the confidence of the willing lay members. The General Committee decided that immediate and urgent action had to be taken, and this prompted a tour of the Cure by members of the General Committee including Archbishop Howard, Gregory, Archdeacon Patrick Cunningham, the Diocesan Secretary, Mrs Jacqueline Mighty, and the Deanery Representative at the time, Rev. Rory Honeyghan.

Initiative in Portland

Special teaching material prepared by the Education Division and Archbishop Gregory and distributed to lay leaders to assist in Bible Studies and with conducting services. Beginning in March 2022, the Church Army was asked to intervene, and has been engaged in an evangelist thrust in the Cure. Activities have included 'walk-throughs', health fairs, residential week-end activities including the conducting of services on Sundays, and the offering of support for the Sunday Schools. Admittedly, it has been an uphill task. The JCMS expresses thanks to Rev. Seymour Blackwood who has been ministering in this area, and the Church Army well supported by the Associate Evangelists who truly immersed themselves in the process. The JCMS has

received pictures of the activities and now awaits a formal report from the Church Armywhich should offer suggestions as to the way forward.

The JCMS is conscious that there are similar situations existing in the Diocese, and it is hoped that the experiences in this initiative in Portland can be used to assist in these situations.

5. CHANGE OF STATUS / RESOLUTIONS

The respective Regional Councils have supported applications for the reclassification of the following Missions:

- i. Mission of the Ascension, Harry Watch, Manchester, to a Chapel of Ease. (Appendix 2)
- ii. The Church of The Holy Spirit, Pepper, St. Elizabeth, to Chapel of Ease. (Appendix 3)

The resolutions will be presented to the Synod for approval.

6. CHURCH/SCHOOL SIGNS

The Society continues to promote the installation of signs at our churches, missions, and schools. The signs not only help to identify the presence of the Diocese in the community, but also provide information on the various activities. There were not many requests for Church signs during the year, but there was increased demand from schools. It has been noticed that a number of signs are in disrepair and in need of renovation. We wish to advise that signs can be renovated at a lower cost than that of replacement. The suppliers will make the assessment and advice thereof. Churches, missions and schools with dilapidated or damaged signs are asked to get in touch with the Secretariat.

Production costs for signs exclusive of General Consumption Tax are as follows:

One (1) two-sided Standard Sign - 48" x 40" or 48" x 34" is Fifty Eight Thousand and Six Hundred Dollars (\$58,600) each.

One (1) two-sided Standard Sign - 48" x40 or 48" or 48" x 34" is Forty Five Thousand Dollars (\$45,000) each.

Requests in writing with the preferred wording are to be submitted to the JCMS office along with a 50% deposit. The balance becomes due on collection. *The JCMS assists by underwriting 50% of the cost of one sign to Missions*. Changes in the dimensions of the signs can be accommodated for smaller facilities.

7. OUTREACH PROGRAMMES

The Society continued to supplement the operational expenses of our Diocesan Children's Homes and other outreach programmes. During the year grants were offered in the amount of \$350,000 as under:

 - \$390,000 to cover utility and maintenance at Olive Road (Mission House)
- 3) Spot Valley Mission
 - \$56,000 for maintenance costs.

The net income for the year ended 2022 was \$2.6 million derived from total revenue and expenditure of \$5.83 million and \$3.23 million respectively. Although total revenue

exceeded the 2021 outcome of \$4.89 million, it was \$1.33 million less than the 2022 projection of \$7.16 million. The income saving is attributed mainly to the reduction in claims on Grant Development Projects and other administrative expenses.

10. INDEBTEDNESS OF MISSIONS

The outstanding amount in mission share for the year 2022 is \$47.5M [2021:\$45.99M]. The JCMS is conscious of the challenges being experienced by the missions, with these being the contributing factors to applications for reclassification to chapels-of-ease. In this regard, the Society will be focusing on strategies targeting these problems during 2023. It should be noted that the budget has always included Current Account Support for the missions. Applications supported by the respective Deanery and Regional Councils, must include information outlining the status of the mission, and the plans for the ministry within the community.

Total contributions for 2022 of \$5.81 million fell short of the projected \$7.16 million by \$1.35 million. Congratulations to the Montego Bay Region which exceed its target of \$2.91 million with a contribution of \$2.97 million, 51% of total Diocesan contributions.

For the seventh consecutive year the Church of the Holy Trinity, West Gate, is the highest contributor in the Diocese with an amount of \$1.30 million, approximately 78% of the total contribution of the Deanery of St. James. The five (5) top contributors for 2022 are:

Commendations are in order for St. Boniface, Pondside, St. Elizabeth - \$109,766 and the Church of the Holy Trinity, Retreat, St. Mary - \$103,198.

The JCMS is financed mainly by the contributions from the Missionary Services. Notwithstanding Canonical requirements, regrettably, some churches, do not participate in this ministry. The contributions of individual churches and missions are reflected in *Appendix* 6

The Society continues to appeal for Attorneys to ensure that funds allocated for the General Purpose Contributions are clearly indicated on the deposit slips, and that these be submitted as soon as possible after the transaction. Only transactions completed by December 31 will be accounted in the current year.

The JCMS welcomes Bishop Minott as Chairman, successor to the late Rt. Rev. Robert Thompson, who retired as Chairman in 2020.
